REQUIREMENTS TO BECOME A MEMBER OF IRSA

In terms of our constitution, there are two options available for a country to be granted membership of IRSA:

Option

1. Membership can be granted to the ISAF Member National Authority (MNA) for that Country who will then be responsible for all forms of Radio Sailing in the Country.

or

2. Membership can be granted to a National Body to whom the ISAF Member National Authority (MNA) has delegated in writing the authority for representing and promoting all forms of Radio Sailing within the country. This organisation will then become the Delegated National Member (DNM) for that country.

Option 1

This will require a letter from the ISAF Member National Authority requesting membership of IRSA and that they represent all forms of Radio Sailing either via a subcommittee or representative elected from within their organisation.

See Appendix 1 for sample documentation.

Option 2

This will require a letter from the ISAF Member National Authority requesting membership of IRSA and stating further that they delegate their responsibility to promote and represent all forms of Radio Sailing to a National Organisation.

See Appendix 2 for sample documentation.

For both options above, the name, postal address, telephone number and email address for the person who will act as the representative must be submitted along with the documentation.
